

ORDINANCE NO. 20-02

CREATING THE POSITION OF PLANNING INCENTIVE GRANT ADMINISTRATOR  
AND AMENDING  
"AN ORDINANCE FIXING AND CONFIRMING THE SALARIES AND  
COMPENSATIONS OF CERTAIN APPOINTIVE AND ELECTIVE OFFICERS  
AND EMPLOYEES OF THE TOWNSHIP OF MANNINGTON IN THE COUNTY OF  
SALEM, NEW JERSEY BEGINNING JANUARY 1, 1968," ADOPTED  
FEBRUARY 22, 1968 AND THE AMENDMENTS AND SUPPLEMENTS  
TO SAID ORDINANCE

**BE IT ORDAINED** by the Township Committee of the Township of Mannington, County of Salem and State of New Jersey:

1. That a need exists for the creation of the position of Planning Incentive Grant Administrator, and

2. In accordance with NJSA 40A:9-9, Kris Alexander is hereby appointed to the position of Planning Incentive Grant Administrator as of January 1, 2020, and

3. Section 1 of "An Ordinance Fixing and Confirming the Salaries and Compensations of Certain Appointive and Elective Officers and Employees of the Township of Mannington in the County of Salem, New Jersey Beginning January 1, 1968," Adopted February 22, 1968 and the Amendments and Supplements to Said Ordinance is hereby further amended and supplemented as follows:

**Section 2.** Section 1 of said Ordinance as amended and supplemented, is hereby further amended and supplemented as follows:

Planning Incentive Grant Administrator - \$1,250.00/Farm - Salary paid upon Settlement of Farmland Preservation. Effective January 1, 2020.

All other terms and provisions of the said ordinance adopted on February 22, 1968 as amended and supplemented shall be and remain in full force and effect, save only as herein expressly amended, supplemented or repealed.

All ordinances or parts of ordinances inconsistent herewith, to the extent of such inconsistencies, be and the same are hereby repealed.

This Ordinance shall take effect and become operative upon its final passage and publication as required by law; and the provisions of this ordinance shall remain in full force and effect until amended, supplemented or repealed.
